How to Enter or Update Your Smith Alumnae Directory On-Line Information

- 1. Go to http://alumnae.smith.edu
- Click on "Alumnae Directory & Email" in the menu on the left. 2.
- 3. Enter your Username and Password, then click "Submit."
 - If you have not previously registered, click on "New User" and follow the directions for registration. You will need your 9 character Smith ID# (AVxxxxxxx) listed on the Quarterly mailing label or obtained by emailing alumnae@smith.edu.
- To update your information in the directory, select "Personal Information" from the menu across the top.
- 5. DO check your personal information; you may be surprised to see what is missing, such as current address, current email address, advanced degrees, current job title, etc.
 - Choose from the following to update information:
 - a/ Update Name
 - b/ Update Home -- enter or update your home mail, phone, & email address (if any)
 - Update Degree -- enter or update graduate/other degree details c/
 - Update Business -- enter or update your work title as well as business name, address, email address d/

How to Find Classmates

(if they have entered and/or updated their Smith Alumnae Directory listing)

- 1. Go to http://alumnae.smith.edu
- 2. Click on "Alumnae Directory & Email" in the menu on the left.
- 3. Enter your Username and Password, then click "Submit".
 - If you have not previously registered, click on "New User" and follow the directions for registration. You will need your 9 character Smith ID# (AVxxxxxxx) listed on the Quarterly mailing label or obtained by emailing alumnae@smith.edu
- Choose "Directory" from the menu across the top. 4.
- Select the type of search you want:
 - Alphabetical allows you to search by Last Name, First Name, and/or Undergraduate Last Name.
 - Academic allows to you to search by Class Year in addition to Last Name, First Name, b/ and/or Undergraduate Last Name.
 - Geographical allows you to search by Home City, Home State, Home Country, Last Name, and/or Undergraduate Last Name.
 - <u>Custom</u> is the most flexible and allows to you search for classmates by Class Year, Last d/ Name, First Name, Undergraduate Last Name, Business or Home City, State, Country, Zip Code, Employer, Occupation, and/or a range of zip codes

For example, I did a custom search to find the names of '72ers in Colorado. I filled in "1972" for Class Year and selected "Colorado" for Home State. I knew there were only 3 of us, but 6 names appeared. The other 3 were 1972 graduates of the Smith College School of Social Work with MSW degrees.

How to Make a Smith Donation/Pledge via the Alumnae Association Secure Web Site

1. Go to http://www.smith.edu/advancement/

Note: This is separate from the Alumnae Association website.

- 2. Look in the panel titled "GIVING" in the upper left portion of your screen.
 - a/ To make a credit card gift on-line, click on "make a gift" and follow step 3.
 - b/ To make a pledge, click on "make a pledge" and follow step 4.
 - c/ To give a gift of stock, call 1-800-2023, option #5. Ruth Bishop, Office of Advancement Operations, is currently the Securities specialist. Her direct line is (413) 585-2681.
- 3. If you clicked on "make a gift", a pop-up form will be displayed for you to complete.

Note: To print the form at any time, press Control & "P" from your Intel/IBM-type PC.

- 3a. You may check to see if your company participates in matching gifts via a drop-down box.
- 3b. You will be asked to enter your name, undergraduate name, current last name, designate whether your gift is for the Alumnae Fund or some special purpose, the donation or pledge amount, and the date of the pledge/donation.
- 3c. You will need to enter a daytime phone number, email address, and mailing address so you can be contacted in case the Alumnae Association office has questions about your pledge/donation information, and to send you confirmations and other communications relating to your gift. (This contact information is not shared.)
- 3d. You can make the gift in one payment or specify extended payments over a number of months. At this time, Smith can accept on-line payments with American Express, Discover, MasterCard, and Visa cards.
- 3e. You may request that your gift be anonymous.
- 3f. You may designate that the gift be made "in honor of" or "in memory of" a family member, friend, or classmate, and may enter an address so an acknowledgement of your gift can be sent by Smith College to the designee.
- 3g. You may choose not to have your name listed as a donor in the Alumnae Fund Campaign Gift Report.
- 3h. You may enter additional comments.
- 3i. To submit the gift/pledge, click on the "Submit" button at the left bottom of the form.
- 3j. To clear the form, click on the "Clear form" button at the right bottom of the form.
- 4. If you clicked on "make a pledge", a pop-up form will be displayed for you to complete.

Note: To print the form at any time, press Control & "P" from your Intel/IBM-type PC.

- 4a. You may check to see if your company participates in matching gifts via a drop-down box.
- 4b. You will be asked to enter your name, undergraduate name, current last name, designate whether your gift is for the Alumnae Fund or some special purpose, the donation or pledge amount, and the date of the pledge/donation.
- 4c. You will need to enter a daytime phone number, email address, and mailing address so you can be contacted in case the Alumnae Association office has questions about your pledge/donation information, and to send you confirmations and other communications relating to your gift.

Note: This contact information is not shared with other College departments.

4d. You can list the schedule in which you intend to fulfill your pledge, specifying up to ten amounts/dates through which you will fulfill your pledge over the current fiscal year.

Note: The fiscal year runs from July 1 through June 30.

- 4e. You may enter comments clarifying your payment schedule.
- 4f. Credit Card Payments: You may request automatic charges to your credit card for the payments you specified in 4d, -or- you may charge the full amount to your credit card on the date specified, -or-you may charge only the first installment to your credit card.

Note: At this time, Smith accepts on-line payments for American Express, Discover, MasterCard, and Visa cards.

- 4g. You may indicate that you will send your payment at a later date.
- 4h. You may designate that the gift be made "in honor of" or "in memory of" a family member, friend, or classmate, and may enter an address so an acknowledgement of your gift can be sent by Smith College to the designee.
- 4i. You may indicate that this gift will be matched by your company.
- 4j. You may request that your gift be anonymous.
- 4k. You may choose to not to have your name listed as a donor in the Alumnae Association Campaign Gift Report.
- 4l. You may enter additional comments.
- 4m. To submit the pledge, click on the "Submit" button at the left bottom of the form.
- 4n. To clear the form, click on the "Clear Form" button at the right bottom of the form.

Mini-Reunion Recipe

- 1. Make a white sauce -- NO! This is going to be really easy -- no assumed knowledge!
- 2. Follow the instructions in the "How to Find Classmates" tutorial located in this newsletter to pull up contact information for classmates in your zip code, or living and/or working in your town, or in your state. You can do multiple searches to get people in communities nearby.
- 3. Select a reasonable, centrally-located restaurant in your community, and a good time of the week for you. Book a reservation that can be contracted, depending on the number of people you're inviting. For dinners, reserve for an early start (6 PM) to catch women going home from work and those who have to get home early after dinner. One option is to select a restaurant with a *prix fixe* with a few options and a glass of wine. I let each classmate order off the menu.
- 4. You can email the group; you can call; or you can send a postcard. I send postcards or letters where I don't have an email. When using e-mail, make the subject obvious, e.g. "Smith '72 Dinner in New York City October 27!" Be sure to include day, date, time and place; RSVP's should come to you.
- 5. The day before the event, send a reminder email with a list of classmates who will be coming and a way to reach you should anyone be running late, need to cancel, etc. Call the restaurant with a "firm" number, but anticipate changes right up to the set hour.
- 6. Serve with wonderful conversation, high spirits and good fun!

Help Keep '72 Financially Sound

It takes money to run the Class of '72. In any five year cycle from one reunion to the next, the class has a number of expenditures. The Alumnae Association recommends that an annual class newsletter be sent (two in the year of the reunion). Newsletters currently cost approximately \$400 for printing and mailing each year. The class is responsible for reimbursing travel expenses of class officers to attend Alumnae Association conferences including the class officers training conference held in the fall following their election and a reunion planning conference on campus for Vice Presidents and class Treasurers two years prior to the reunion. In addition, there are travel expenses to be reimbursed to the Vice Presidents who observe the Class of '71's reunion in the year prior to our class reunion.

Your class officers have been good stewards of your dues. In many cases officers have absorbed any expenses incurred as a result of holding a class office. However, we do not want to limit class officers to only those who can afford to pay their own way. The Class of '72 has not collected dues in the last eight years (at a minimum). We currently have \$11,229.37 in the class treasury. We have calculated that if class annual expenses average \$1,400 per year (\$400/newsletter and \$1,000/partial travel reimbursement) for the next 33 years (until our 65th reunion) and if our funds earn a rate of return equal to the rate of inflation and if expenses increase at the rate of inflation, then a current balance of \$46,200 would cover all remaining class expenses through 2037. We are not attempting to fund this entire amount now, but would like to keep our class treasury sound. Smithies from prior classes have urged us to put our treasury in a healthy fiscal condition while we are young, because they have found it much more difficult to raise funds as their classmates age. (Did you know that Smith alumnae returning for reunions beyond their 65th are treated as guests of the college?)

The current class officers are asking you to voluntarily contribute to the Class of '72 treasury at whatever level you feel comfortable. Please be aware that class dues are <u>not</u> contributions to Smith College Alumnae Fund. We know that some classmates previously paid "lifetime" class dues. Unfortunately we do not have records of who you are. However, please feel free to self-designate your lifetime status when you return the form below. Also, if anyone has a list of lifetime class dues payers, please send it to Melissa Hield. We also encourage anyone who is interested in being a class officer for the 2007-2012 cycle to contact Nancy Jianakoplos – please see contact information on the back page.
