From your Treasurer

For the period 6/27/07 through 12/31/08: Our beginning class funds balance was \$8,669. Our expenditures were \$1,277 for 35th Reunion, \$1,101 reimbursement for class officer travel to Northampton (in September 2007 for the on-campus training conference for Smith volunteers) and \$370 for 2008 newsletter. That totals \$2,745. Our income from our "one-time-for-five years" class dues payment request has brought in \$3,876 from 52 classmates. Other income includes: 35th Reunion attendance reimbursement \$4,347, interest earned on our funds \$98 and one class officer reimbursed the class for travel pay at \$370. The total income is \$8,691. The ending class funds balance is \$14,615. Thank you to the first 52 gracious women who paid class dues so promptly.
